PROJECT MANAGERS REPORT:

Dear Members & Friends.

Thank you to everyone who has supported DOHA through this past year. We greatly appreciate your kind and generous support.

As food insecurity continued to be an ongoing problem in many Nations post Covid, we decided to focus on disaster relief projects.



Some of our Partners requested more assistance in helping to provide food aid to their communities. The cost of living continues to increase as inflation rises, affecting the cost of produce in the marketplace.

We were pleased to partner again with Pr Barry Silverback to address food insecurity in communities in India and Nepal. This project was completed.

We also completed our Project with KCC, to provide food and non-food aid to communities in Turkey, following the devastating earthquake.

Through both of these Projects, we again learned the importance of working with our Partners on the ground. Trusting them to advise us of the greatest needs in their Community and to implement the Projects on our behalf.

We continued to partner with African Action International (AAI) in a number of ongoing Community Development and Vocational Training Projects in Kenya and Uganda. There was a setback in the Community Garden in Kenya following storm and flood damage. We are working with AAI to address this in 2024.

We also supported a number of welfare projects in Fiji, Philippines and South Sudan, through specific non-tax deductible donations via our Project account.

In 2023, we held the DOHA SSIN at the Yarra Yarra Golf Club in April, our DOHA AGM in May and a presentation at Sale Baptist Church in September.

The support we receive from our Board, Members, Friends, Donors, Partners and the Board is greatly appreciated. We could not function without you!

2023 PROJECT OVERVIEW:

India & Nepal Food Aid Relief Project:

We partnered with Pr Barry Silverback in providing much needed food aid to communities in India & Nepal.

Lessons learned:

After the Covid-19 Pandemic, we discovered the need for Food Aid had substantially increased in the Countries we were already partnering in. This project came about after discussions with our Partner. By sending the funds to allow our Partner to implement the Project urgently was the best approach to meet this need.

Food/non-food aid in Turkey Earthquake Disaster relief Project

We partnered with KCC in providing much needed food/non-food aid to communities in Turkey who were directly impacted by the Earthquake.

Lessons learned:

Working with locals on the ground is essential for knowing what is required and the priorities of who are the most vulnerable.

African Action International (AAI) Community Development Projects:

We are partnering with AAI in the following projects:

AAI Water Bore Project in Kenya.

This Project will install a new bore well, solar driven pump, overhead storage tank and security fencing to provide the following:

- Clean water available to the local community from a Safe Water Point
- * Water for the purposes of irrigation in times of drought to grow food for the poor.
- Clean water for the students at the School for hand washing, cleaning, and drinking.

AAI Fencing Project in Kenya.

This Project will provide Vocational Training for the same community who are creating Kitchen Gardens. It soon became apparent that fencing was required to protect the gardens. This Project will train the community how to build and maintain fencing.

AAI Water and Solar Project Uganda.

This Project will provide the School and community with constant clean water (needed for drinking, cooking and sanitation) and solar power to provide lighting for safety and for the Medical Clinic.

AAI Kitchen Garden and Poultry Project in Kenya.

This Project will help families improve their food security by enabling them to grow their own food (vegetables, fruit, herbs/spices and poultry).

Lessons learned:

Some lessons learned from AAI Community Development Projects are that by using local labour this assists local families improve their income generation. That the vision and impetus for the project must be undergirded by the local people for success. That this project needs to be self-sustainable to be ongoing.

The Board meets to discuss projects being supported, fundraising and marketing strategies, finances, policies & procedures, conflicts of interest, feedback & complaints, partnerships, personnel, training, changes to DOHA Rules and Constitution and planning of overseas trips.

AUDIT:

The Treasurer will ensure that an external financial audit is undertaken once every 12 months and the audit report and accounts will be forwarded to the Chairman and Board Members.

ANNUAL GENERAL MEETINGS:

The end of the financial year for DOHA is December 31.

The Board may determine the date, time and place of the DOHA AGM.

The notice convening the AGM must specify that the meeing is an Annual General Meeting.

The ordinary business of the AGM shall be:

- (a) to confirm the minutes of the previous annual general meeting and of any general meeting held since that meeting; and
- (b) to receive from the Board reports upon the transactions of the DOHA Inc. during the last preceding financial year.
- **In the event of a Board Member position becoming vacant, a vote (2/3 majority of quorum present) will be taken during AGM to appoint replacement board member, as nominated by current Board and DOHA Members prior to AGM.
